

Passage of Bills

The House was informed that the Speaker of the Senate appointed Senators to Mediation Committees to consider the Employment (Amendment) Bill (Senate Bill No. 11 of 2022) and the Natural Resources (Benefit Sharing) Bill (Senate Bill No. 6 of 2022). Following the appointment, the Mediation Committees will consider the respective Bills and submit their versions for consideration by the Houses of Parliament.

- 2. Development of measures to mitigate digital exclusion. The Motion seeks for the National Assembly to resolve that the Kenya Government, through the Ministry of Information, Communications and the Digital Economy, formulates a policy to:
- a. regulate internet billing by Internet Service Providers (ISPs) by providing metered billing of internet use based on consumption in order to mitigate exploitation and secure economic interests of internet users in line with Article 46 of the Constitution; and,
- b. require the ISPs to develop and deploy quality metered billing systems capable of monitoring customer usage, convert to readable details and creating invoices based on consumption and align their metrics with the value the customers get from various internet services.
- 3. That the House adopts the Report of the Departmental Committee on Trade, Industry and Cooperatives on its consideration of the Economic Partnership Agreement between the European Union and the Republic of Kenya, laid on the Table of the House on Tuesday, 23rd April 2024 and pursuant to the provisions of Section 8(4) of the Treaty Making and Ratification Act of 2012, approves the ratification of the Economic Partnership Agreement between the European Union and the Republic of Kenya.
- 4. Messages

Passage of Bills

The Senate received messages from the National Assembly regarding the passage of the following Bills;

The Kenya Policy on Public Participation

The Sessional Paper No. 3 of 2023 on the Kenya Policy on Public Participation was laid on the Table of the Senate for consideration. The Paper was committed to the Standing Committee on Justice, Legal Affairs and Human Rights (JLAC), for consideration. The Committee will be required to scrutinize the Paper, undertake public participation, and submit a report to the Senate within 30th days.

Motions

The following Notice of Motions were given on the Floor of the House:

- 1. Development of a Law for Social Risk Management in Infrastructure Development Projects in Kenya. The Motion seeks for the Senate to resolve that:
 - The National and County Governments develop a Social Risk Management Policy that outlines the standards, guidelines and procedures for guiding infrastructure and other development projects both at the national and county governments; and
 - The national executive establishes an independent multi-sectoral agency under the authority of the Cabinet Secretary in charge of Social Security and Protection to design a mechanism that can factor in the inclusion of Social Impact Assessments standards and monitor their implementation in infrastructure and other development projects in Kenya.
- 2. Status of Pending Bills in Counties. The Motion seeks for the Senate to:
 - Recommend that all County Governments pay verified pending bills amounting to less than Kshs1 Billion by the end of this financial year and those above Kshs1 billion by the end of the financial year 2024/2025; and
 - Resolve that;
- a. County Governments prioritize payment of pending bills as a first charge on the County Revenue Fund failure to which the subsequent quotas budget releases will not be done;
- b. County Governments shall only pay pending bills contained in their respective procurement plans
- c. Supplementary budgets for county governments are prepared in the 3rd Quarter to curb instances of arbitrary re-allocations out of the approved budget estimates; and
- d. County governments shall conduct public participation while formulating supplementary budgets, failure to which the Controller of Budget (CoB) shall not approve the supplementary budgets.

- The Competition Authority issued a Cease and Desist order against the Rural Private Hospitals Association of Kenya (RUPHA) following its issuance of a circular making recommendations on prices, fees and terms of trade to its members and directing its members to reduce the acceptance of the National Hospital Insurance Fund (NHIF) policy as a means of payment by sixty (60) percent, effective from the 15th December, 2023. RUPHA, its agents and members were directed to, with immediate effect, cease and desist from implementing the said circular and refrain from making further recommendations regarding prices, fees and terms of trade to any class of its members until the ongoing investigation by the Authority is concluded.
- 5. The Canadian Overseas Packaging Industries Limited (the Offeror) has made a take-over offer to acquire up to 100% of the issued ordinary shares in the share capital of East African Packaging Industries Limited (EAPI) with Company No. C.33/71 for a cash consideration in accordance with the Companies Act, No. 17 of 2015, Laws of Kenya (the Companies Act).

From the Counties

Nairobi City County – The County published the waived fees and charges for the general retail alcoholic licenses for the small bar, medium bar, bar and restaurant categories for Financial Year 2023/2024

Mombasa County – The County waived all accumulated and preceding penalties and/or interest on parking for a period between 8th April, 2024 and 30th April, 2024



GENERAL UPDATES

Draft AI Code of Practice

The Kenya Bureau of Standards (KEBS) published the draft Information Technology - Artificial Intelligence - Code of Practice for AI Applications for public consultation. The draft, provides a set of recommendations intended to help organizations develop, provide, or use Artificial Intelligence (AI) systems responsibly in pursuing objectives and meet applicable requirements, obligations related to interested parties and expectations from them.

The draft Code proposes to be applicable to any organization, regardless of size, type and nature, that provides or uses products or services that utilize AI systems. It includes the following:

- approaches to establish trust in AI systems through transparency, explainability, controllability, etc.
- engineering pitfalls and typical associated threats and risks to AI systems, along with possible mitigation techniques and methods; and
- approaches to assess and achieve availability, resiliency, reliability, accuracy, safety, security and privacy of AI systems.

Comments on the Draft Code should be submitted to the Managing Director, KEBS by 13th June 2024.





















Code of Ethics for business in Kenya

The Global Compact Network Kenya (GCNK), in collaboration with the Kenya Association of Manufacturers (KAM) and the Kenya Private Sector Alliance relaunched the Code of Ethics for Business in Kenya. The Code of Ethics for Business in Kenya is a guide to ethical business practices in Kenya. It seeks to promote and enhance business ethics, aligning with the Ten Principles of the UN Global Compact in Human Rights, Labour Standards, Environment, and Anti-Corruption.

Public Notice on postal courier services

The Communications Authority of Kenya (CA) issued a Notice on the illegal provision of postal courier services. In the Notice, CA indicates, "it has come to the attention of the Authority that a number of authorised public service vehicles and e-commerce players are offering courier services without obtaining the requisite licence from the authority." A person operating without the requisite licenses commits an offence and shall be subject to penalties upon conviction.

Draft Banking (Penalties) Regulations, 2024

The Draft Regulations are designed to enforce penalties for violations related to the Banking Act, its associated regulations, Prudential Guidelines, and directions issued by the Central Bank of Kenya (CBK). The Regulations propose hefty fines for financial institutions that commit various offenses such as opening, relocating, or closing banks and branches without prior approval from the CBK.

The Statute Law (Miscellaneous Amendment) Act 2024

The Act gazetted on 26th April, 2024 amends various statutes such as:

- The Value Added Tax Act to remove denatured ethanol from the list of VAT-exempt supplies which creates an economic safety net and competitive edge for local denatured ethanol manufacturers, particularly millers and sugar manufacturers, who face challenges with cheaper imports. It also exempts the supply of gas meters from VAT to enhance access to clean energy by low-income households.
- Industrial Training Act to align the remittance date of the training levy with PAYE remittance to the Kenya Revenue Authority, aiming to boost employer compliance. The levy will fund intern wages and support technical and vocational education training and higher education operations.

Online Food and Groceries Delivery Platforms Market Study

The Competition Authority of Kenya conducted a Market Study on the Online Food and Groceries Delivery Platforms. The study findings reveal a lack of explicit regulations on online platforms in Kenya, underscoring the urgent need to address deficiencies in the regulation of digital platforms comprehensively. Key players in the Kenyan online food and grocery delivery market include Glovo, Jumia Food, Uber Eats, Bolt Food, and Jumia. Additionally, major retail chains such as Carrefour, Naivas, Quickmart, and Chandarana operate their own platforms for online groceries' delivery. Among other things, the study recommends continuous monitoring of the online food and groceries market by the CAK to identify and address anticompetitive behavior. It also suggests analyzing contract terms between platforms and users to identify issues related to superior bargaining positions and collaboration with other relevant regulators to address e-commerce-related consumer concerns and data privacy issues, along with advocacy initiatives to encourage self-regulation among platforms through the development and implementation of codes of conduct.
